This team focuses on promoting Jolayemi Chartered Accountant through advertising, social media engagement, and brand awareness strategies, ensuring the store reaches a wider audience.

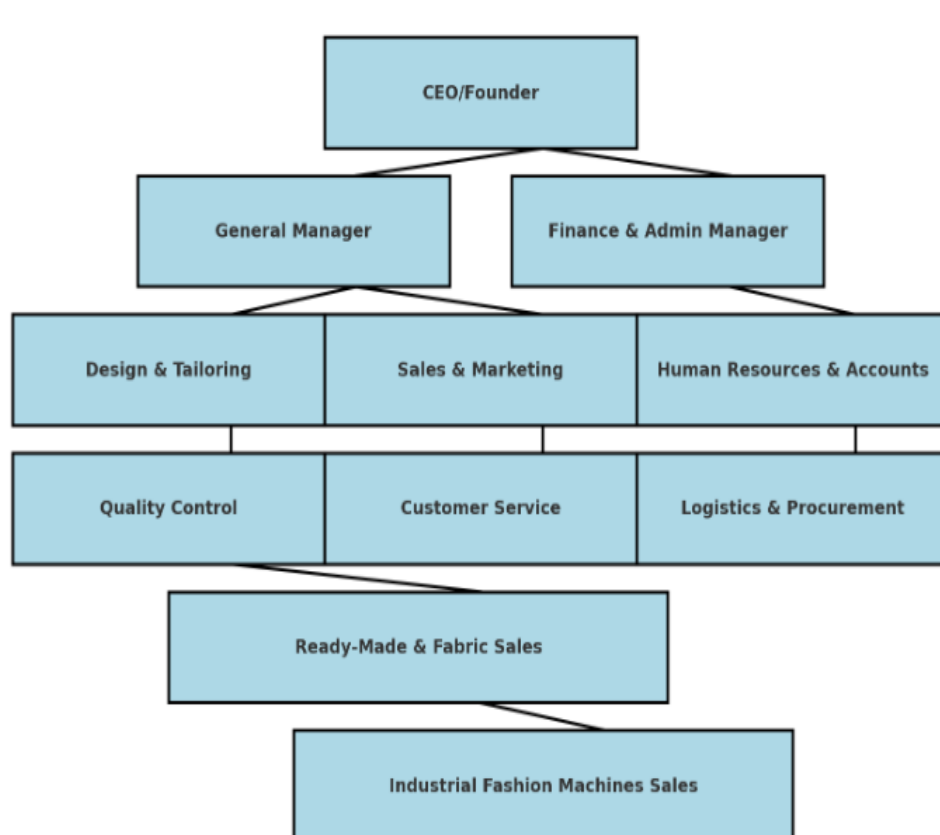
5. **Quality Control Department**
